Wayne Kellum, zoning administrator, appeared before the Board with four quotes for the printing of the "Zoning Regulations for Unincorporated Territory of Douglas County, Kansas." Mr. Kellum recommended that the Board accept the low quote from Encore Copy Corps, Lawrence, for 100 copies, in the amount of \$230.40. After discussion it was moved by Mrs. Bradley that this recommendation be approved, seconded by Mr. Cragan, and carried unanimously.

*Pub. Works,
Punch signs*

Mike Dooley, public works director, appeared before the Board with three quotes for the purchase of 63 signs for the detour signing of Project 23C-1245-01, Eudora Wakarusa Bridge Rehabilitation. Mr. Dooley recommended that the Board accept the low quote of National Sign Company, Ottawa, Kansas, in the amount of \$975.23. After discussion it was moved by Mr. Cragan that this recommendation be approved, seconded by Mrs. Bradley, and carried unanimously.

*Pub Works:
Proj. 23C-1189-01*

Mr. Dooley then presented an Authority and Method Procedure Form covering Project No. 23 C-1189-01 (SOS 472 (5)) which consists of 0.132 miles of grading 7.3 miles West and 1.0 mile South Baldwin, West. County funds in the approximate amount of \$11,100 will be available for the matching of federal funds to finance construction work on this project. After discussion it was moved by Mrs. Bradley that this document be approved, seconded by Mr. Cragan, and carried unanimously.

Proj. 23C-1188-01

Mr. Dooley then presented an Authority and Method Procedure Form covering Project No. 23 C-1188-01 (SOS 432 (1)) which consists of 0.113 miles of grading 0.1 mile South Leocompton, East. County funds in the approximate amount of \$10,300 will be available for the matching of federal funds to finance construction work on this project. After discussion it was moved by Mrs. Bradley that this document be approved, seconded by Mr. Cragan, and carried unanimously.

Route 1273

Mr. Dooley then presented a Request for Secondary Road Designation Form for the extension of F.A.S. Route 1273 from the west side of Clinton to Bloomington Park, and for the addition to the F.A.S. system a section of road known as Douglas County Route 4 from the west side of Clinton, north and east to the end of Douglas County Route 4. After discussion it was moved by Mrs. Bradley that this Request for Secondary Road Designation Form be approved, seconded by Mr. Cragan, and carried unanimously.

*Widen Landfill
Road*

It was moved by Mr. Cragan and seconded by Mrs. Bradley that the minutes reflect that the Board has found and determined that it is necessary to lay out, alter, and widen Douglas County Landfill Road, Road Project No. 553, and that to carry out its lawful powers and duties, it is necessary to acquire easements to lands or interests and rights therein and other property and rights located in Douglas County as hereinafter described by the exercise of its power of eminent domain; except that no right, title, or interest in or to the oil, gas, and minerals under or in the lands set out below is to be condemned. The legal description of the real estate being taken for public use is:

Beginning at a point 14.18 feet East of the Northwest corner of the Northeast Quarter (N.E. $\frac{1}{4}$) of Section 2, Township 12 South, Range 19 East of the Sixth Principal Meridian, Douglas County, Kansas, said point being on the North line of said Quarter Section; thence S. 88° 47'35" E. on the North line of said Quarter Section a distance of 1,301.42 feet; thence S. 1°12'25" W. a distance of 40.00 feet; thence N. 88°47'35" W. parallel with the North line of said Quarter Section a distance of 904.23 feet; thence S. 36°25'15" W. a distance of 71.10 feet; thence S. 08°34'45" E. a distance of 70.71 feet; thence S. 36°25'15" W. a distance of 80.00 feet; thence N. 52°53'42" W. a distance of 397.60 feet to the point of beginning, less existing highway. The above contains 0.86 acres, more or less, exclusive of existing highway, all in Douglas County, Kansas.

Motion carried unanimously.

No further business, the Board adjourned to meet on Thursday, April 30, 1981.
