Mr. McDermott then presented the Board the contract for the Fourth Year Model Community Prevention System to be funded by the Alcohol and Drug Abuse Services of SRS. The amount of award from SRS is in the amount of \$30,000. After discussion it was moved by Mr. Cragan that this contract be approved, seconded by Mrs. Bradley, and carried unanimously.

Mr. McDermott then notified the Board that Jim Scheurich will terminate on July 10, 1981.

The Board discussed two Equipment Rental Agreements between Douglas County and Century Office Products, Inc., Lawrence. One agreement is for a Toshiba 8102 Copier with a monthly payment to Century Office Products in the amount of \$285 and is for a period of 48 months. This machine is to be located in the Douglas County Judicial and Law Enforcement Center in the Clerk of the District Court Office. The other agreement is for a Minolta 520 Copier and Stand with a monthly payment to Century Office Products in the amount of \$170 and is for a period of 48 months. This machine is to be located in the basement of the Douglas County Courthouse. After discussion it was moved by Mr. Cragan that these Equipment Rental Agreements be approved, seconded by Mrs. Bradley, and carried unanimously.

At 9:08 a.m. it was moved by Mr. Cragan and seconded by Mrs. Bradley that the Board adjourn to go into executive session to discuss personnel matters with Don Gordon, county appraiser. Motion carried. The Board resumed regular session at 9:30 a.m.

At 9:31 a.m. it was moved by Mrs. Bradley and seconded by Mr. Cragan that the Board adjourn to go into executive session to discuss personnel matters with Irene Redding. Motion carried. The Board resumed regular session at 9:51 a.m.

Mike Dooley, public works director, appeared before the Board with Resolution No. 81-28. By this resolution the Board resolves that any and all speed zone resolutions established prior to January 1, 1981 are hereby rescinded and based on the recommendation of an engineering and traffic investigation, a maximum speed limit of 55 miles per hour be and the same is hereby determined and declared to be a reasonable and safe maximum speed limit for all hard surface roads within the Douglas County highway system except those portions of roadways designated in Resolutions Numbers 81-29 through 81-53 which are being passed concurrent with this resolution. This maximum speed limit does not apply to paved township roads within Douglas County. This speed limit shall become effective when appropriate signs are erected upon the highway system. Following an engineering study and recommendation, subsequent resolutions shall establish reduced or altered speed limits at specific locations. After discussion it was moved by Mrs. Bradley that Resolution No. 81-28 be approved, seconded by Mr. Cragan, and carried unanimously.

Mr. Dooley then presented the Board Resolution Numbers 81-29 through 81-53 whereas the Board finds and determines upon the basis of an engineering and traffic investigation that the speed limit for the following described county roads or highways as set by K.S.A. 8-1560, is greater than is reasonable or safe under the conditions found to exist on the following described county road or highway under the jurisdiction of the Board:

(1) Resolution No. 81-29 - Be it resolved by the Board of County Commissioners of Douglas County, Kansas, that a speed limit of 10 miles per hour be determined and declared to be a reasonable and safe speed limit for the following described county road or highway:

All roads, lanes, and travelways with the Property Boundary lines of the Wells Overlook County Park.

(2) Resolution No. 81-30 - Be it resolved by the Board of County Commissioners of Douglas County, Kansas, that a speed limit of 20 miles per hour be determined and declared to be a reasonable and safe speed limit for the following described county road or highway:

All roads, lanes, and travelways within the Property Boundary lines of the Douglas County Lone Star Lake Park.

(3) Resolution No. 81-31 - Be it resolved by the Board of County Commissioners of Douglas County, Kansas, that a speed limit of 30 miles per hour be determined and declared to be a reasonable and safe speed limit for the following described county road or highway:

Beginning at a point on the North line of the Southeast Quarter (S.E. ¼) of Section 11, Township 14 South, Range 18 East of the Sixth Principal Meridian in Douglas County, Kansas, said point being 455.2 feet East of the Northwest corner of said Southeast Quarter (S.E. ¼) and the intersection of Douglas County Route No. 1 and Douglas County Route No. 10, thence Southwesterly on an assumed bearing of S. 18°00'00" W. a distance of 12.88 feet, thence S. 14°22'00" W. a distance of 1007.99 feet to the P.C. of a curve to the left with a radius of 955.4 feet, thence Southerly on said curve an arc distance of 269.45 feet to the P.T. of said curve, thence S. 1°48'00" E. a distance of 127.27 feet to the P.C. of a curve to the left with a radius of 214.2 feet, thence Southeasterly on said curve an arc distance of 177.77 feet to the P.T. of said curve, thence S. 49°48'00" E. a distance of 396.64 feet to the P.T. of a curve to the right with a radius of 716.8 feet, thence Southerly on said curve an arc distance of 487.5 feet to the P.T. of said curve, thence S. 10°48'00" E. a distance of 142.18 feet to the P.C. of a curve to the left with a radius of 319.6 feet, thence Southeasterly on said curve an arc distance of 244.44 feet to the P.T. of said curve, thence S. 54°48'00" E. a distance of 146.76 feet to the intersection of Douglas County Route No. 1-E with Douglas County Route No. 1-W.
