

It is therefore by the Board of County Commissioners of Douglas County, Kansas, considered and ordered that certain alley being located adjacent to Lots 1 through 24, inclusive, and Lots 26, 28, 30 and 32, all in North East Central Subdivision, a Subdivision in that part of the City of Lawrence formerly known as North Lawrence, Douglas County, Kansas, be vacated, subject however to the reservations unto the City of Lawrence, Kansas, and the owners of any lesser property rights, for public service utilities, rights-of-ways and easements for public service facilities, now in existence and use. Speed limit  
set 6-13-81

The Board then considered Resolution No. 81-55. The Board finds and determines upon the basis of an engineering and traffic investigation that the speed limit for the following described county road or highway, to-wit: Beginning at the Southwest corner of the Southwest Quarter (S.W.¼) of Section 6, Township 13 South, Range 21 East of the Sixth Principal Meridian in Douglas County, Kansas, said point being on the center line of Douglas County Road No. 81, thence North on the West line of said Southwest Quarter (S.W.¼) and the center line of said Douglas County Road No. 81 a distance of 40.0 chains to the Southwest corner of the Northwest Quarter (N.W.¼) of said Section 6, said point being on the center line of Douglas County Road No. 17, thence North on the West line of said Northwest Quarter (N.W.¼) and said Douglas County Road No. 17 a distance of 40.0 chains to the Northwest corner of said Northwest Quarter (N.W.¼), said point being on the center line of Douglas County Road No. 6-A, thence East on the North line of said Section 6 and on the center line of said Douglas County Road No. 6-A to the Northwest corner of Section 5, Township 13 South, Range 21 East, thence East on the North line of the Northwest Quarter (N.W.¼) of said Section 5 and on the center line of said Douglas County Road No. 6-A on an assumed bearing of N. 90°00'00" E. a distance of 1502.2 feet to the point of intersection of said Douglas County Road No. 6-A and the extension of the center line of Douglas County Road No. 677, thence S. 1°05' E. on the center line of said Douglas County Road No. 677 a distance of 1386 feet, thence N. 89°30' E. a distance of 626.3 feet, thence S. 1°05' E. a distance of 435 feet, thence N. 89°30' E. a distance of 518 feet, said point being at the West City Limits of a vacated portion of Eudora, Kansas, and on the center line of Third (3rd) Street of said vacated portion of Eudora, Kansas, thence N. 89°44' E. a distance of 1080.35 feet and terminating at said point, as set by K.S.A. 8-1560, is greater than is reasonable or safe under the conditions found to exist on the above described county road or highway under the jurisdiction of this Board. After discussion it was moved by Mrs. Bradley that the Board adopt Resolution No. 80-55 establishing a speed limit of 30 miles per hour on the above described county road or highway, seconded by Mr. Cragan, and carried unanimously.

No further business, the Board adjourned to meet on Thursday, July 23, 1981.

- (2) From Douglas County Rural Water District No. 4, Lawrence, Kansas. The cost of the alterations, if any, shall be paid by the county on company easement.
