Salvage Yard

At the hour of 9:30 a.m., the Board discussed a Conditional Use Permit to allow the legal operation of an existing salvage yard located approximately a mile to a mile and one-half east of Lawrence on the south side of Highway 10 being operated by Ralph L. and Doris J. Rees. Also in attendance was Dan Young, county counselor; Garner Stoll, director of the planning department; Dean Palos and David Guntert, staff members of the planning department; Ralph Rees, salvage yard operator; Lorene Davison, adjoining landowner to the salvage yard; and Kay Hodge, representing the zoning office. The discussion was recorded by a court reporter. The Conditional Use Permit was approved by the Board on July 16, 1980, subject to four conditions with one of the conditions being the following:

That a screening fence at least six (6) feet high be installed along the north, south and west sides of the property and additional landscaping be provided along the north side. This should be completed within one year.

The above stated condition has not been accomplished. After discussion by Dan Young, David Guntert, Ralph Rees, and Lorene Davison it was moved by Mrs. Bradley that the Board take this matter under advisement, seconded by Mr. Cragan, and carried unanimously.

No further business, the Board adjourned to meet on Thursday, July 30, 1981.
