



Mr. Dooley then presented a tenant contract for right-of-way easement for Project 23C-1297-01, Formerly 23RS-1528(4) between the Board of Commissioners of Douglas County and Timothy Jones, tenant on property owned by Elmer H. Smith and Elnora T. Smith, husband and wife, for reducing pasture area by 1.9 acres, in the lump sum of \$10.00. After review of this contract it was moved by Mr. Cragan that it be approved, seconded by Mrs. Bradley, and carried unanimously.

Valleyview:
 Rate increase
 11/1/81

Kathy Hamilton, Valleyview Administrator, appeared before the Board to recommend the following rate increases for Valleyview Care Home, effective November 1, 1981:

Private room:	\$28 per day
2-bed wards:	\$26.50 per day
4-bed wards:	\$24.50 per day

Rate structure is changed from a set monthly charge to a daily rate. Residents requiring a higher level of care (assistance with meals, toileting, or close supervision) would be charged \$1.00 per day in addition to the basic daily rate. After discussion it was moved by Mrs. Bradley that this recommendation be approved, seconded by Mr. Cragan, and carried unanimously. It should be noted that this rate increase should stand for a full year (barring unforeseen circumstances), however they should be re-evaluated April of 1982 when the state adjusts its medicaid rate.


