This item is a Text Amendment to the Conditional Use Permit Section/Continuation of Home Occupations--Amending Section 19-4 of Article 19 in the County Zoning Regulations for the Unincorporated Territory of Douglas County, Kansas, by adding Subsection 26 dealing with the continuation of home occupations. After discussion it was moved by Mrs. Bradley that the Board send this item back to the planning commission and ask them to reconsider their decision on the basis of Counselor Young's letter dated November 10, 1981, seconded by Mr. Cragan, and carried unanimously.
