Treasurer Ruth Vervynck appeared before the Board with a quote from Logan Business Machines, Inc., Topeka, Kansas, for a Sharp Calculator, Model 2164-B in the amount of \$196 and a Sharp Calculator, Model CS 2182 in the amount of \$286, for a total amount of \$482. Mrs. Vervynck recommended that this quote be approved. After discussion it was moved by Mr. Cragan that this recommendation be approved, seconded by Mrs. Bradley, and carried unanimously.

Jerry Kemberling, noxious weed director, appeared before the Board with a quote from Westheffer Company, Inc., Lawrence, Kansas, for a 300 gallon FG Sprayer with accessories in the amount of \$2700. Mr. Kemberling also presented a quote from Mid States, Eudora, for the purchase of two 55-gallon drums of 2,4-D weed spray in the total amount of \$902. Mr. Kemberling recommended that both of these quotes be approved. At the hour of 10:00 a.m., as advertised, the Board opened bids for four cars with two trade-ins to be used by the Sheriff Department. Three bids were received. Sheriff Johnson recommended that the Board accept the low bid from Landmark Ford, Lawrence, in the amount of \$31,206.20, to be taken from the 1981 Budget. After discussion it was moved by Mr. Cragan that this recommendation be approved, seconded by Mrs. Bradley, and carried unanimously.

Mike Dooley, public works director, appeared before the Board with five telephone quotes for the purchase of six 10' x 25', 10-oz. treated canvas tarps with grometts. Mr. Dooley recommended that the Board accept the low quote from Contractor's Supply Company, Kansas City, Missouri, in the amount of \$277.50. After discussion it was moved by Mrs. Bradley that this recommendation be approved, seconded by Mr. Cragan, and carried unanimously.

Mr. Dooley then presented the Board three quotes for the purchase of 25,000 tons of stockpiled rock. Mr. Dooley recommended that the Board accept the quote from Killough, Inc., Ottawa, Kansas, in the amount of \$71,250. After discussion it was moved by Mr. Cragan that the Board accept the low quote from N. R. Hamm Quarry, Inc., Perry, Kansas, in the amount of \$69,750, in opposition of Mr. Dooley's recommendation, seconded by Mr. Neis, and carried unanimously.

Babbitt

Mr. Dooley then presented the Board a contract for right-of-way for Project No. 81-4, Bridge No. 12.41N-11.50E, between the Board of Commissioners of Douglas County and Dale E. Babbitt and Norma L. Babbitt, husband and wife, for 0.93 acres of right-of-way easement, in the lump sum of \$1006.20. This lump sum payment includes allowance for plowing and fertilizing 0.74 acres, more or less of farmland, abstracting, and irregularity of boundary. After
