Mr. Dooley then presented a Request for Construction Project (Pavement Marking Demonstration Program), whereas the State Highway Commission of Kansas has been designated as Agent for Douglas County. Federal funds are available to the County under the Pavement Marking Demonstration Program as authorized by Section 205 of the Highway Safety Act of 1973, 23 U.S.C. 151. The State Highway Commission is hereby requested to program for construction those sections of FAS routes and local roads as listed in the Project Summary and map which includes the following:

(1) Center Striping	157.97 miles
(2) Edge Striping	138.07 miles
(3) R.R. Approach Markings	2
(4) Channelization	0.50 miles

The County agrees to furnish to the State Highway Commission, prior to programming for construction, all known accident data for the sections of road included in the project. This accident data is to cover the four years immediately preceding the application of the pavement marking. The County further agrees to submit annually, for the duration of the program, the number, rate, and severity of accidents on those sections of roads included in the project for the period since marking application. After discussion it was moved by Mr. Neis that this Request for Construction Project (Pavement Marking Demonstration Program) be approved, seconded by Mrs. Bradley, and carried.

Jerry Kemberling, noxious weed director, appeared before the Board with two quotes for the purchase of 2,4-D. Mr. Kemberling recommended that the Board accept the low quote from Mid-States Ag Chemical, Inc., Eudora, Kansas, for the purchase of 6120 gallons in 5-gallon cans at a price of \$6.85 per gallon and 400 gallons in 1-gallon cans at a price of \$8.15 per gallon.
