Fairgrounds:

The Board met with auctioneer Hal Crady to discuss the process for conducting an auction to sell the Hougland House at the Douglas County 4-H Fairgrounds on Saturday, April 17, 1982, at 10:00 a.m. Douglas County purchased this property as an addition to the fairgrounds from Sherman F. Hougland and Maxine P. Hougland, husband and wife, at 1920 Harper, Lawrence, in the fall of 1980 and early 1981. The property consists of a three bedroom ranch style house plus approximately two acres. The house must be removed within 90 days after the purchase at the auction. Mr. Crady stated that he would conduct this auction to sell the house for a fee of 6% or \$200 minimum and the county will do the legal advertising. After discussion it was moved by Mr. Neis that the Board hire Mr. Crady to conduct this auction to sell the house at 1920 Harper, seconded by Mr. Cragan, and carried unanimously.
