This contract is without monetary remuneration and shall terminate immediately upon completion of construction of said project. Method of sediment disposal shall be placement of material to the original ground level starting at the West end of the quarry and proceeding to the East. After discussion it was moved by Mr. Cragan that this Contract for Temporary Construction Easement for Disposal of Excess Embankment Material be approved, seconded by Mr. Neis, and carried unanimously.
