1983 Budget  
Hearing

At the advertised hour of 9:00 a.m., the Board met to convene budget hearing on the 1983 General Fund and County Budget for the year 1983. In addition, at this hearing, the budget for revenue sharing expenditures for 1983 was reviewed in accordance with the published notice. Several interested citizens appeared to discuss various aspects of the budgeting process and after a thorough review of both the county budget and the revenue sharing budget for the year 1983, it was moved by Mr. Cragan that the budgets be adopted as presented, seconded by Mrs. Bradley, and carried.

At the advertised hour of 9:30 a.m., the Board convened a hearing on the 1983 budgets for maintenance of the various sewer districts existing in Douglas County. No public discussion was held on this matter and after a complete review it was moved by Mr. Cragan that these maintenance budgets be adopted as presented, seconded by Mrs. Bradley, and carried.

Break tie for  
Grant Township

At the hour of 10:00 a.m., as was published, the Board of County Commissioners acting as County Board of Canvassers determined the Republican precinct committeeman for Grant Township. In the August 3, 1982, primary election Arthur Heck and Robert Palmateer, both of Route 4, Lawrence, received six write-in votes. According to K.S.A. 25-3108 in any election for which the county board of canvassers makes the final canvass, if any two or more persons have a tie vote, such board shall determine by lot which person is nominated or elected, as the case may be. After the election tie, the county commissioners consulted with their legal counsel and then decided to use the hat-drawing method rather than the flip of a coin or drawing of straws to name the winner. Mrs. Bradley held a hardhat containing the names of Arthur Heck and Robert Palmateer over her head while Rita Westerhaus, administrative office assistant for the commission, drew the name of Arthur Heck as the elected Republican precinct committeeman for Grant Township.

Fremont Hornberger, maintenance supervisor, appeared before the Board to recommend that the area south and west of the playground in Broken Arrow Park be reseeded. Mr. Hornberger stated that this could be accomplished at an approximate amount of \$200. After discussion it was moved by Mr. Cragan that this recommendation be approved, seconded by Mrs. Bradley, and carried.

Mike Dooley, public works director, appeared before the Board and presented the Board three quotes for the purchase of 50 aluminum, 30", stop signs. Mr. Dooley recommended that the Board accept the low quote from Newman Signs, Jamestown, North Dakota, in the amount of \$16 each for a total of \$800. After discussion it was moved by Mr. Cragan that this recommendation be approved, seconded by Mrs. Bradley, and carried.

Proj. 23C-1215-01

Mr. Dooley then presented a document titled Authority to Award Contract Commitment of County Funds on Project No. 23 C-1215-01, which document indicates that a low bid received on the above project was from Taylor Construction Co., Inc., Lenexa, Kansas, in the amount of \$311,983.45 for grading and bridge at Sta. 150+30, and that county funds on this project is \$68,637 which funds are hereby pledged to be remitted to the State of Kansas on or before September 13, 1982. By this document the Board resolves that we find the bid described above to be acceptable and that the Secretary of Transportation is hereby authorized to award the necessary contracts for the completion of the work on this project as was bid. After review it was moved by Mr. Cragan that this Authority to Award Contract Commitment of County Funds be executed and forwarded to the Secretary of Transportation, seconded by Mrs. Bradley, and carried.
