Rezoning Fickel

At the hour of 9:00 a.m., the Board again reviewed Item No. 11 from the Lawrence-Douglas County Planning Commission minutes dated August 11, 1982. This item is a request to rezone 12.05 acres from A (Agriculture) to B-2 (General Business). The property is generally described as being located on the south side of U.S. Highway 40 approximately 1500 feet west of County Road 1025 and approximately 1/4 mile east of Big Springs. This request was submitted by Homer D. Fickel, owner of record, for himself. This item was discussed by the Board on September 23, 1982, and at that time, it was voted unanimously by the Board to take this matter under advisement until 9:00 a.m. today. This item comes to the Board with a recommendation for denial by a 7-1 vote from the Lawrence-Douglas County Planning Commission and by the recommendation for denial by the Lawrence-Douglas County Planning Staff based upon the following reasons:

- (1) Location of land is inconsistent with land use (zoning) requested as suggested by the Douglas County Guide Plan.
- (2) Zoning requested is inconsistent with surrounding land use (agricultural). Some of the permitted uses in B-2 could devalue the adjacent residential properties.
- (3) There is sufficient, properly zoned land for the proposed use which is vacant or undeveloped in nearby Big Springs.
- (4) The need for the requested size (12.05 acres) has not been substantiated for the proposed use.

After discussion it was moved by Mr. Neis that the Board concur in the recommendation of the Lawrence-Douglas County Planning Commission and the Lawrence-Douglas County Planning Staff, subject to the above described conditions, seconded by Mr. Cragan, and carried unanimously.
