Amend Child
Sup. Reimb. Agree

The Board then discussed Amendments to Child Support Reimbursement Agreement presented by Jerry Harper, District Attorney. Under the existing Child Support Reimbursement Agreement, the Secretary of the State Department and Rehabilitation Services (SRS) reimburses the District Attorney's budget for 75% of its child support collection expenditures. In addition, the county receives 15% of certain intrastate collections which reimburse Kansas Aid to Families with Dependent Children (AFDC) expenditures. Because of cuts in funding by the federal government, the SRS reimbursement to the District Attorney's office is being cut from 75% to 70%. The District Attorney has eliminated the 1/2 attorney position in the child support division. This will essentially eliminate any negative impact on the District Attorney's budget. After discussion it was moved by Mr. Neis that these Amendments to Child Support Reimbursement Agreement be approved, seconded by Mrs. Bradley, and carried.

Data Process.

George Little, data processing director, appeared before the Board with three quotes for the purchase of 350,000 sheets blank stock paper, 14-7/8 x 11. Mr. Little recommended that the Board accept the quote from Moore Business Forms, Inc., Topeka, Kansas, in the amount of \$2439.
