Purch jackets

Mr. Dooley appeared before the Board to recommend the purchase of seventeen quilted jackets from Swingster, Shawnee Mission, Kansas, in the amount of \$22 each, plus \$40.50 to cover the cost of imprinting each of these jackets with a logo identifying them as awards for safe driving from the Douglas County Department of Public Works. The total of this recommendation is in the amount of \$414.50. After discussion it was moved by Mr. Neis that this recommendation be approved, seconded by Mr. Cragan, and carried unanimously.

Wayne Kellum, zoning administrator, and Roy Sturtridge, representing McGrew Real Estate, appeared before the Board to request the approval of an easement for a private road for purposes of obtaining approval for a building permit. Mr. Sturtridge indicates that this request for a private road easement is for Lot No. 2, 5, and 8 of the preliminary plat of Yankee Tank Subdivision (not a platted area). After discussion it was moved by Mr. Neis that the Board rescind the minutes of January 18, 1982, pertaining to the approval of private road request for Lots 4 and 5 of the preliminary plat of Yankee Tank Subdivision and that the revised request be approved subject to the following conditions:

- (1) That a 70 foot private road easement to serve Lots 2, 5, and 8 of the preliminary plat of Yankee Tank Subdivision be recorded in the Register of Deeds Office before a building permit is issued, and
- (2) When the public sewer or lagoon is available to serve these lots, that the owners of Lots 2, 5, and 8 connect to the sewer or lagoon.

Motion seconded by Mr. Cragan, and carried unanimously. Mr. Sturtridge was instructed that this private road will not be the responsibility of the township or county to maintain. It should be noted that this private road will serve as an ingress and egress for the third and final residences.
