Wayne Kellum, zoning administrator, and Scott Killough, representing Killough, Inc., Ottawa, Kansas, appeared before the Board to request renewal of two temporary use permits for asphalt plants on the following described real estate:

The South one-half of the Southwest one-quarter of Section 1, Township 13, Range 18, Douglas County, Kansas

The Northeast one-quarter of Section 15, and the Northwest one-quarter of Section 14, all in Township 15, Range 18, Douglas County, Kansas

These renewals to become effective on February 27, 1983 and to expire on February 27, 1985. Both of these special temporary use permits are subject to the conditions enumerated therein. After full discussion on the matter it was moved by Mrs. Bradley that the request for the renewal of the special temporary use permits be approved, seconded by Mrs. Hiebert, and carried unanimously.

This temporary use permit is to become effective on January 24, 1983 and will expire on January 24, 1985. This temporary use permit is subject to the conditions enumerated therein. After discussion it was moved by Mrs. Bradley that the request for the special temporary use permit be approved, seconded by Mrs. Hicbert, and carried unanimously.
