Mr. Dooley then presented a Memorandum of Agreement between the Board of County Commissioners of Douglas County and the Board of County Commissioners of Franklin County. Douglas County and Franklin County share a common border as a road and bridge system on that border and a certain bridge is located on the South line of Douglas County on the South side of Section 14, Township 15 South, Range 17 East and on the North line of Franklin County on the North side of Section 23, Township 15 South, Range 17 East and is more commonly described as being 150 feet East of the Osage County line. Plans have been developed for a replacement bridge, easements, and arrangements for utility adjustments made by both counties. KSA 68-1122 allows adjacent counties to share costs of improvements on mutual borders in whatever cost sharing method or percent as is agreeable by both Board of County Commissioners. The required county matching money shall be divided between the counties at a ratio
