Attorney George Catt appeared before the Board to request that the date for a planning item be changed. This item is CUP-12-3-82 which is a Conditional Use Permitted Upon Review for the operation of a rock quarry containing approximately 40 acres. The property is located approximately six miles south of Lawrence on the west side of Willow Springs Township Road 1-A. It is legally described as the SW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 12, Township 14 South, Range 19 East of the 6th Principal Meridian, all located in Douglas County, Kansas, and submitted by Robert R. Bigsby. The date for this hearing is set for March 16, 1983, at 10:00 a.m. Attorney Catt represents some of the landowners near the rock quarry site. After discussion it was moved by Mrs. Bradley that the hearing date for this item be changed from March 16, 1983, at 10:00 a.m. to March 30, 1983, at 9:00 a.m., seconded by Mrs. Hiebert, and carried unanimously.

The Board of County Commissioners of Douglas County met in regular adjourned session with two members of the Board present. Mrs. Bradley was absent due to attending a weed conference in Great Bend.

Approved the minutes of the meeting of March 7, 1983.

Ruth Foster, Valleyview administrator, appeared before the Board to recommend employment of the following:

(1) Lesa J. Martin, in the position of nurse aide, permanent, part-time, at the rate of \$3.35 per hour, effective February 26, 1983.

(2) Susan A. Pichelman, in the position of nurse aide, permanent, part-time, at the rate of \$3.35 per hour, effective February 26, 1983.

After discussion it was moved by Mrs. Hiebert that this recommendation be approved, seconded by Mr. Neis, and carried.

Mrs. Foster then notified the Board that Phyllis Anderson terminated on February 27, 1983.

Mrs. Foster then notified the Board that Brenda Waite has gone from temporary, part-time, to permanent, full-time, effective February 26, 1983.

Mrs. Foster then requested that Bonnie Foster be put on an inactive status effective March 12, 1983. After discussion it was moved by Mrs. Hiebert that this request be approved, seconded by Mr. Neis, and carried.

At the advertised hour of 9:00 a.m., the Board sits to hear the Petition of the City of Lawrence for an Order in the matter of the Vacation of that portion of Valley Lane laying South of the North line of Lot 7, Valley Addition to the City of Lawrence, Kansas, extended east to the West line of Lot 1, of the Replat of Lots 1, 2 and 3, Block 1, Raintree Subdivision, an Addition to the City of Lawrence, Douglas County, Kansas. The petitioner states:

(1) That the petitioner is a duly incorporated City of the First-Class with in the State of Kansas.

(2) That this petition is made pursuant to the authority of K.S.A. 12-504 et seq.

(3) That no private rights will be injured or endangered by such vacation.

(4) That the public will suffer no loss or inconvenience by said vacation.

(5) That said order of vacation should reserve unto the petitioner and the owners of any lesser property rights for public service utilities, rights-of-ways and easements for public service facilities now in existence and use.

(6) That the Governing Body of the City of Lawrence, Kansas, did on the 8th day of February, 1983, unanimously approve and authorize the filing of this petition and all proceedings hereunder.

The petitioner is represented in this instance by Counselor Gerald L. Cooley, and no other persons appeared in protest of this petition. The petitioner presented to the Board an Affidavit in Proof of Publication which indicates that legal notice in the newspaper of record for Douglas County has been given. After a complete review of the details of this requested vacation, it was moved by Mrs. Hiebert that the following Order of Vacation be adopted: Now on this 9th day of March 1983, the above entitled matter comes on for hearing before the Board of County Commissioners of Douglas County, Kansas, upon the petition of the City of Lawrence, Kansas, for an order vacating that portion of Valley Lane laying South of the North line of Lot 7, Valley Addition to the City of Lawrence, Kansas, extended east to the West line of Lot 1, of the Replat of Lots 1, 2 and 3, Block 1, Raintree Subdivision, an Addition to the City of Lawrence, Douglas County, Kansas.
