Mr. Dooley then presented the Board an Agreement between Southwestern Bell Telephone Company and Douglas County for Project 23C-1492-01. Douglas County intends to improve a portion of Douglas County Road No. 9-A and replacement of Bridge No. 11.86N-15.00E, described as follows: Beginning at a point 155.86 feet South of the Northwest Corner of Section 20, Township 13 South, Range 20 East, thence South 1600.00 feet and terminating at said point. After discussion it was moved by Mrs. Hiebert that this Agreement be approved, seconded by Mrs. Bradley, and carried unanimously.

Mr. Dooley then presented the Board a contract for right-of-way for Project No. 23C-1666-01, Road No. 51-B, between the Board of Commissioners of Douglas County and Emma Mae Crawford and Dale I. Crawford, wife and husband, for 0.044 acres of right-of-way easement, 0.102 acres of temporary easement for construction, and 8 rods of barb fence, in the lump sum of \$126.50. This lump sum payment includes allowance for two gate posts and three corner fence posts. That part of the Northeast Quarter (N.E.1) of Section 15, Township 15 South, Range 20 East of the Sixth Principal Meridian in Douglas County, Kansas, described as follows:

Commencing at the Northeast corner of said Northeast Quarter (N.E.1), thence South of the East line of said Northeast Quarter (N.E.1) on an assumed bearing of S. 0°00'00" E. a distance of 1188.71 feet to the point of beginning of the land to be described, thence N. 90°00'00" W. a distance of 33.00 feet, thence S. 18°41'57" W. a distance of 68.62 feet, thence S. 11°18'36" E. a distance of 112.18 feet, thence S. 90°00'00" E.
