Rock Quarry  
Deny

At 9:15 a.m., the Board considered the matter of the application of Robert R. Bigsby for a Conditional Use Permit for operation of a commercial rock quarry located on a tract of approximately 40 acres, in the SW  $\frac{1}{4}$  of the NE  $\frac{1}{4}$  of Section 12, Township 14 South, Range 19 East of the 6th Principal Meridian, which is approximately six miles south of Lawrence on the west side of Willow Springs Township Road 1-A. Those present were Dan Young, county counselor; Price Banks, Lawrence-Douglas County planning director; David Guntert, Lawrence-Douglas County Planning staff member; Wayne Kellum, zoning administrator; and Mike Dooley, public works director. It was moved by Mrs. Bradley that the Board deny the Conditional Use Permit based on the Findings of Fact and Conclusions prepared by Dan Young, seconded by Mrs. Hiebert, and carried unanimously. A copy of the Findings of Fact and Conclusions is on file in the office of the County Commission.

Pub. Works  
Purch fuel

Mike Dooley, public works director, appeared before the Board with two quotes for the purchase of regular gasoline, unleaded gasoline, and diesel fuel. Mr. Dooley recommended that the Board accept the low quote from Zaroco, Inc., Lawrence, for the following: 2000 gallons of regular gasoline at \$0.978 per gallon, 3950 gallons of unleaded gasoline at \$1.008 per gallon, and 2450 gallons of diesel fuel at \$0.803 per gallon. After discussion it was moved by Mrs. Hiebert that this recommendation be approved, seconded by Mrs. Bradley, and carried unanimously.

CM-K rock

Mr. Dooley then recommended that the Board accept the bid from N. R. Hamm, Inc., Perry, for 900 tons of CM-K cover material rock at \$5.90 per ton, and the bid of Killough, Inc., Ottawa, for the purchase of 4600 tons of CM-K cover material rock at \$5.50 per ton. After discussion it was moved by Mrs. Hiebert that these recommendations be approved, seconded by Mrs. Bradley, and carried unanimously.
