Mr. Dooley then presented the Board Resolution No. 83-19, whereas, pursuant to K.S.A. 68-102 and K.S.A. 68-102(a), 1982 Supp., the Board of County Commissioners has determined that, in its judgement, it is necessary that the following described portion of Douglas County Road 117 be vacated: Begin at a stake 6.00 chains North of the Southeast corner of the Southwest Quarter of Section 34, of Township 13 South, Range 18 East, thence variation 10°-10' E., North on Quarter Section line in Section 34, 15.50 chains to stake and terminating at said point. Notice of its intention to vacate said roadway has been given as required by law, and hearing on said proposal to vacate has been held. After discussion it was moved by Mrs. Bradley that this resolution be approved, seconded by Mrs. Hiebert, and carried unanimously.

Mr. Dooley then presented the Board Resolution No. 83-20, whereas, the director of Public Works of Douglas County, Kansas, did after conducting a proper engineering study, recommend the relocation of a portion of Federal Aid Secondary Route No. 1369 for the purpose of eliminating sharp turns, the center for said relocated road being described as: Commencing at the Southwest corner of the Southeast Quarter (S.E. 1/4) of Section 34, Township 13 South, Range 18 East of the Sixth Principal Meridian in Douglas County, Kansas, thence North on the West line of said Southeast Quarter (S.E. 1/4) a distance of 2.23 chains to the point of beginning, thence North on the West line of said Southeast Quarter (S.E. 1/4) to the Northwest corner of said Southeast Quarter (S.E. 1/4) and terminating at said point, consisting of approximately 0.47 miles. The relocation of a portion of Federal Aid Secondary Route No. 1369 is found by the Board of County Commissioners of Douglas County, Kansas, to be necessary, said improvement to be known as Douglas County Road No. 704 as above described. Said road shall be established, pursuant to K.S.A. 68-114, under the authority of the Board of County Commissioners by the director of Public Works and his assigns. After discussion it was moved by Mrs. Bradley that this resolution be approved, seconded by Mrs. Hiebert, and carried unanimously.
