Procedure Form

Mike Dooley, public works director, appeared before the Board and presented an Authority and Method Procedure Form covering Project No. 23C-1817-01 (BRO 464 [3]) which consists of 0.218 miles of grading, RCB Bridge, 1.5 mi. N. US-56 and 2.3 miles E. Osage County line, R. The Secretary of Transportation is hereby authorized to proceed to contract the above-noted items of work and County funds will be available for the matching of Federal funds to finance construction work on this project. The Secretary of Transportation is authorized to proceed in accordance herewith under the provisions of the agreement dated July 24, 1975. Mr. Dooley then presented a Certification of Real Property Acquisition Procedures for the same project. This certifies that all real property acquired for the project was done so in compliance with listed procedures which are required by Federal and State law. After discussion it was moved by Mrs. Bradley that these documents be approved, seconded by Mrs. Hiebert, and carried unanimously.

Mr. Dooley then presented a document titled Authority to Award Contract Commitment of County Funds on Project No. 23 C-1666-01, formerly BRO-1053(1), which document indicates that a low bid received on the above project was from Bryan-Ohlmeier, Overland Park, Kansas, in the amount of \$67,656.10, for grading and bridge station 40+32, and that county funds on this project is \$14,885 which funds are hereby pledged to be remitted to the Controller of the Secretary of Transportation of the State of Kansas on or before January 9, 1984. By this document the Board resolves that we find the bid described above to be acceptable and said Secretary of Transportation is hereby authorized to award and execute the necessary contracts for completion of the work on this project as covered by such bid. After review it was moved by Mrs. Bradley that this Authority to Award Contract Commitment of County Funds be executed and forwarded to the Secretary of Transportation, seconded by Mrs. Hiebert, and carried unanimously.

phone system

Les Zerman, ComTec Telecommunication Consultant, Overland Park, Kansas, appeared before the Board to discuss Phase I and II services for purchasing a new telephone system for Douglas County. ComTec proposes to perform and complete Phase I of the study, including a formal presentation in our office, no later than ninety days after acceptance. The total fee for Phase I services will be sixty hours at \$50 per hour, for a total of \$3000. The basic fee would be payable upon the acceptance of their report. After discussion it was moved by Mrs. Hiebert that the Board approve Phase I, seconded by Mrs. Bradley, and carried unanimously. Phase II will be evaluated upon completion of Phase I.
