Road Identification

Mike Dooley, public works director, appeared before the Board and presented Resolution No. 84-9. The Board of County Commissioners recognizes a need to identify and mark township roads within the county. By this resolution such a road identification system is hereby established and adopted as the only official call number of roads. An identification system and map has been prepared by the public works department which assigns an identification number to all travelled roads with the rural portion of the county. After discussion it was moved by Mr. Neis that this resolution be approved, seconded by Mrs. Hiebert, and carried unanimously.

Mr. Neis left the meeting at 10:30 a.m. to attend a committee hearing of the House Ways and Means Committee in Topeka.

Jerry Kemberling, noxious weed director, appeared before the Board and presented an Agreement to Treat Noxious Weeds between the Board of Commissioners of Douglas County and the Kansas Department of Transportation which relates to a stated price for services rendered in connection with the spraying of the State of Kansas highway right-of-way. After discussion it was moved by Mrs. Hiebert that this Agreement be approved and that the following prices for services be set within it: For the use of equipment - \$11 per hour; for the services of one person - \$8.50 per hour; and for the services of the second person - \$4 per hour. Motion seconded by Mrs. Bradley and carried.

Mike Dooley, public works director, appeared before the Board with three proposals for geo-technical services for the Wastewater Facilities Study at Lone Star Lake. The proposals were requested on the recommendation of Ponzer-Sears-Youngquist, P.A., Olathe, Kansas, the consulting engineers conducting the Lone Star Lake Wastewater Facilities Study. Mr. Dooley recommended that the Board accept the low proposal from Terracon Consultants, Inc., Lenexa, in the estimated amount of \$975. After discussion it was moved by Mr. Neis that this recommendation be approved, seconded by Mrs. Bradley, and carried.

Mr. Dooley then presented the Board a Statement of Basis for Offer on Project No. 23C-1804-01, Road No. 56, the owners of which are John F. Vesecky and Sharon A.
