Bob Thorn, consulting engineer with Finney & Turnipseed, Topeka, Kansas, was also present. Three bids were received. After a brief review it was moved by Mrs. Hiebert that the Board take the bids under advisement for review by Bob Thorn and the public works department, and to make a recommendation at a later time, seconded by Mr. Neis, and carried unanimously.

Mr. Dooley then presented the Board a Notice to Bidders for the purchase of two new roadside mowers. Mr. Dooley recommended that bid opening be at 10:00 a.m., March 29, 1984, in the Office of the Douglas County Board of Commissioners. After discussion it was moved by Mrs. Hiebert that this recommendation be approved, seconded by Mr. Neis, and carried unanimously.

Mr. Dooley then recommended the approval of an Agreement between Douglas County, Kansas, and BG Engineering, Inc., Manhattan, Kansas. This Agreement is relative to normal field survey, topographical survey, balanced grading plans, culvert designs, right-of-way survey, construction cost, contour maps, bridge layouts, and detailed bridge plans for off-system grading and bridge located in the North $\frac{1}{2}$ of Section 33, Township 12 South, Range 18 East (15.89N-4.50E). The amount of the Agreement is \$5200. After discussion it was moved by Mrs. Hiebert that this recommendation be approved, seconded by Mr. Neis, and carried unanimously.

Sufficient funds of Douglas County are now, or will be, available and are hereby pledged to KDOT in the amount and at the time required for the supplementing of federal funds available for the completion of this project. After discussion it was moved by Mr. Neis that this Request for Construction Project be approved, seconded by Mrs. Hiebert, and carried unanimously.
