Mike Dooley, public works director, appeared before the Board to recommend that the Board accept the quote from Humboldt Manufacturing Company, Chicago, Illinois, for test equipment in the amount of \$2479. Mr. Dooley also recommended that the Board accept the low quote for individual items for sand density testing, and the pocket tachometer, from Soiltest, Inc., c/o Pacific Scientific, Overland Park, Kansas, in the amount of \$138.50. After discussion it was moved by Mr. Neis that these recommendations be approved, seconded by Mrs. Bradley, and carried.

Reg. Const. Proj.
KDOT
Rt. 1039.5

Mr. Dooley then recommended for approval a Request for Construction Project to be forwarded to the Kansas Department of Transportation whereas KDOT is requested to program for construction that portion of local Route No. 1039.5 located 1.5 miles West and 2.6 miles North of Intersection of US-40 and K-10 in Lawrence, which includes grading, culverts, and bridge, for an estimated total for project to be \$140,000. Surveys and plans will be prepared by Schwab-Eaton, P.A., consulting engineers. Sufficient funds of Douglas County are now, or will be, available and are hereby pledged to KDOT in the amount and at the time required for the supplementing of federal funds available for the completion of this project. After discussion it was moved by Mr. Neis that this Request for Construction Project be approved, seconded by Mrs. Bradley, and carried.
