The Board then discussed a Site Plan Review (SP-4-10-84). This site plan is for a used car sales lot to be located just east of Eudora on old Highway 10, submitted by Thomas E. Cyr. The planning staff recommended approval of the above referenced site plan subject to the following conditions:

- (1) Site plan name for the purpose of describing the proposed use;
- (2) Type of surfacing material to be used on the car sales lot;
- (3) Number of required parking spaces and the number to be provided;
- (4) Location and amount of illumination for exterior lighting;
- (5) Screening of the trash area; and,
- (6) Sales lot to be further delineated to show parking spaces and aisleways.

After discussion it was moved by Mr. Neis that the Board concur in the recommendation of the Planning Staff subject to conditions (1) thru (6) as described above, but with condition (7) being added as follows:

- (7) The advertising sign must be attached to the side of the 12'x12' building at the south end of the property.

Motion seconded by Mrs. Hiebert and carried unanimously.

The Board then discussed a Site Plan Review (SP-4-12-84). This site plan is for an antique shop to be located on the northeast corner of the Airport Road and U.S. Highway 24/40 (Miller's Subdivision), submitted by Charlie Steinbacher for Paul and Mary Lou Miller. The Planning Staff recommended approval of the above referenced site plan subject to the following conditions:

- (1) If any outdoor storage is placed upon the property it shall be screened with a view-reducing fence or landscaping;
- (2) Location of the trash storage area be shown on the site plan and screened;
- (3) Location of a sign shall be in conformance with the B-3 regulations; and,
- (4) Type of traffic barrier called for on the site plan be shown on the plan.

After discussion it was moved by Mrs. Hiebert that the Board concur in the recommendation of the Planning Staff subject to conditions (1) thru (4) as described above, seconded by Mr. Neis, and carried unanimously.
