Ruth Foster, Valleyview administrator, appeared before the Board with a quote from Kennedy Glass, Inc., Lawrence, for installation of some interior sliding storm windows for the east windows in the kitchen at Valleyview Care Home. This quote is for five windows that measure 4'x4' and one fixed plexiglas panel to go around the air conditioner. The five windows would cost a total of \$675 and the fixed panel around the air conditioner would cost \$142 installed, for a total amount of \$817. After discussion it was moved by Mr. Neis that this quote be approved, seconded by Mrs. Hiebert, and carried unanimously.

The letter further states that no dairy can be permitted to service as well as furnish any type of equipment to anyone within the State of Kansas. The Board reviewed a proposal from the firm of Barrand Egan and Company that would provide for audit services for the various departments of Douglas County for the year 1984, with that report to be presented upon its completion. This proposal states that the services will be performed at their regular hourly rates and the maximum fee for calendar year 1984 will not exceed \$32,000 exclusive of Federal compliance audit requirements. If the State determines that additional agencies must be included as part of the county audit, these agencies, along with any Federal compliance auditing will be billed separately.
