Don Gordon, county appraiser, requested inventory valuation per square foot to be increased to amounts suggested as follows:

Mr. Keen is requesting the Special Temporary Use Permit for a Music Festival which would have 8 to 10 groups playing from 10:00 a.m. to 10:00 p.m. on August 18 and 19, 1984. The property consists of 40 acres and is leased by Jim Blackwell. It is located approximately 2 miles east of Zaroco. They would like to video tape the groups, sell beer and food. The Board discussed the health, safety and general welfare of surrounding property owners. After much discussion it was moved by Mr. Neis to deny the Special Temporary Use Permit because they have not approved any in the past and did not want to set a precedent for future requests, seconded by Mrs. Hiebert, and carried unanimously.
