1st Quarter report

Ted McFarlane, Douglas County ambulance service director, appeared before the Board and presented the Douglas County Ambulance Service Financial Highlights for the first quarter of 1984.

K. Look - computer programming

Mr. McFarlane then requested that the Board approve the payment of \$750 to Mr. Kurt Look for computer programming completed to date. This is in addition to \$500 approved previously and is in return for a total of 250 hours of programming time. Mr. Look has agreed to work for approximately one-half of the original price quote. After discussion it was moved by Mrs. Hiebert that this request be approved, seconded by Mr. Neis, and carried unanimously.

Extension Council
Discuss 1985 budget

The Board met with members of the Douglas County Extension Council, represented by Ralph Leonard, chairman, and with Dr. Bob Newsome, who is representing the Director of Extension at Kansas State University, to discuss the budget for the Extension Council for the period January 1, 1985 to December 31, 1985. After a complete review of the budget as it was presented, which totaled \$282,500 and which included an appropriation of the Douglas County tax funds of \$206,908, it was moved by Mr. Neis that the budget be adopted and that the county budget appropriations be so set. Motion seconded by Mrs. Hiebert and carried unanimously by all five members of the group voting in accordance with the terms of K.S.A. 2-610 as amended.

Sitting as a Board of Equalization for Personal Property, the Board heard an appeal as set out in Docket No. PP 02-84. This appeal was by The World Company, doing business as Sunflower Cablevision, Lawrence, Kansas, the firm being represented by Attorney Martin Dickinson. The appeal was relative to assessed valuation on cable television equipment. Don Gordon, county appraiser, presented documents and reasons for the market value assigned Sunflower Cablevision's equipment for 1984. At that time counsel relayed that the 1984 guidelines were being rescinded. After discussion it was agreed that this matter would be taken up again tomorrow morning, Thursday, May 31, 1984, at 8:30 a.m.
