The Board of County Commissioners of Douglas County met in regular adjourned session with all members of the Board present.

Approved the minutes of the meeting of June 27, 1984.

The Board approved Commissioners Cancellation Order No. 3268. Order is on file in the office of the County Clerk.

Ruth Foster, Valleyview administrator, notified the Board of the following terminations: Regina Patterson on June 15 and Mabel Seele on June 29, 1984.

Mrs. Foster then recommended employment of the following:

- (1) Cherry D. Kennedy, in the position of weekend cook, temporary, part-time, at the rate of \$3.50 per hour, effective June 16, 1984.
- (2) Tina L. Hilliard, in the position of certified nurse aide, temporary, part-time, at the rate of \$3.55 per hour, effective June 18, 1984.
- (3) Ellen M. Kampfe, in the position of laundry aide, temporary, part-time, at the rate of \$3.35 per hour, effective June 20, 1984.
- (4) Catherine L. Payne, in the position of certified nurse aide, temporary, part-time, at the rate of \$3.55 per hour, effective June 21, 1984.
- (5) David L. Hodges, in the position of maintenance supervisor, permanent, full-time, at the rate of \$6 per hour, effective June 25, 1984.

After discussion it was moved by Mr. Neis that these recommendations be approved, seconded by Mrs. Hiebert, and carried unanimously.

Mrs. Foster then recommended the following probationary raises effective June 16, 1984: Dolores Palmer from \$7.50 per hour to \$7.60 per hour, Beatrice Brooks from \$3.55 per hour to \$3.65 per hour, and Gloria Newman from \$3.75 per hour to \$3.85 per hour. After discussion it was moved by Mrs. Hiebert that these recommendations be approved, seconded by Mr. Neis, and carried unanimously.

Mrs. Foster then presented the Board a quote from Chris Sterett to alter 24 pairs of draperies for Valleyview Care Home in the amount of \$10 per pair for the unlined draperies, \$15 per pair for the lined draperies, and \$2 per pair to rehem the sides of the draperies. After discussion it was moved by Mrs. Hiebert that this quote be approved, seconded by Mr. Neis, and carried unanimously.

Phil Leonard, emergency preparedness/risk management coordinator, appeared before the Board to recommend merit increases for the following employees, effective July 1, 1984:

- (1) Lillian B. Harris, Current Range No. 7, Step A, Rate \$9684.22 per year, to Range No. 7, Step 1, Rate \$10,403.90 per year.
- (2) John C. Kasberger, Current Range No. 16, Step A, Rate \$8700.12 per year, to Range No. 16, Step E, Rate \$9354.02 per year.
- (3) Kenneth L. Harmon, Current Range No. 16, Step 4, Rate \$7320.04 per year, to Range No. 16, Step 1, Rate \$7890.22 per year.

After discussion it was moved by Mrs. Hiebert that these recommendations be approved, seconded by Mr. Neis, and carried unanimously.
