John Young, engineering technician IV in the public works department, notified the Board that Kevin Fulks terminated on July 6, 1984.

Mr. Young then recommended the employment of Dennis Anderson, in the position of ET III, at a salary of \$15,800 per year, effective July 30, 1984. After discussion it was moved by Mrs. Hiebert that this recommendation be approved, seconded by Mr. Neis, and carried unanimously.

Mr. Young then recommended that Rita Fulks be reclassified from clerk-steno to administrative office assistant, at an annual salary of \$14,883, effective July 14, 1984. This is an increase of 10% of her current salary of \$13,530.92. After discussion it was moved by Mrs. Hiebert that this recommendation be approved, seconded by Mr. Neis, and carried unanimously. The Board noted that the new public works director may change this if he so desires.

Mr. Young then opened five quotes for the purchase of wood, sign posts. Mr. Young recommended that the Board accept the low quote from Kerr-McGee Chemical Corporation, Kansas City, Missouri, in the amount of \$1638.75. After discussion it was moved by Mrs. Hiebert that this recommendation be approved, seconded by Mr. Neis, and carried unanimously.

Mr. Young then presented the Board four verbal quotes for the purchase of four 14.00-24, 12-ply motor grader tires. Mr. Young recommended that the Board accept the quote of Farmers Coop Association, Lawrence, in the total amount of \$1080, as these tires have a 4-year road hazard warranty. After discussion it was moved by Mr. Neis that this recommendation be approved, seconded by Mrs. Hiebert, and carried unanimously.
