amendment to Item No. 13. This amendment requires sufficient grade and alignment stakes to be set by a licensed engineer or land surveyor to insure that the subdivision improvements were built according to the approved road plans. This item comes to the Board with a recommendation of approval from the Planning Commission as follows:

21-707. OTHER PUBLIC IMPROVEMENTS. (a) Construction standards for all other public improvements, such as curbs, gutters, streets, alleys, storm sewers, and storm drainage, shall be according to the standards of the City of Lawrence; and where required, according to the standards of Douglas County (through the County Engineer) in the unincorporated area of Douglas County. Construction standards promulgated by the respective engineers are incorporated herein by reference.

(b) In the unincorporated area of Douglas County, sufficient grade and alignment stakes shall be set by a licensed professional engineer or licensed land surveyor, engaged by the subdivider at time of construction, to assure compliance with plan, profile and drainage of roads and streets and such other public improvements as proposed, as submitted with the final plat and approved by the County Engineer. Such compliance shall be certified in writing to the County Engineer by the licensed professional engineer or licensed land surveyor, performing said work.

After discussion it was moved by Mr. Neis that the Board concur in the recommendation of the Planning Commission, seconded by Mrs. Hiebert, and carried unanimously.

At 11:24 a.m. it was moved by Mr. Neis and seconded by Mrs. Hiebert that the Board adjourn to go into executive session to discuss personnel relating to the selection of the public works director. Motion carried. The Board resumed regular session at 11:52 a.m.

No further business, the Board adjourned to meet on Thursday, July 19, 1984.

Phil Leonard, emergency preparedness coordinator, appeared before the Board to recommend the position in his office be reclassified from Clerk-Typist II to the position of Secretary I at a salary of \$981 monthly. This position should be available mid-August. After discussion it was moved by Mrs. Hiebert that this recommendation be approved, seconded by Mr. Neis, and carried unanimously.

B. Cram *Term*

Ted McFarlane, Douglas County ambulance service manager, notified the Board that Barbara K. Cram will terminate on July 20, 1984.

S. Todd *Employ*

Mr. McFarlane then recommended the employment of Susan M. Todd, in the position of secretary/dispatcher, at a salary of \$12,895 per year, which includes \$1200 per year for EMT pay, to be effective July 17, 1984. After discussion it was moved by Mrs. Hiebert that this recommendation be approved seconded by Mr. Neis, and carried unanimously.
