Mr. Young then presented the Board a contract for right-of-way for Project No. 30 C-1951-01, Road No. 393 (Rd. I.D. No. 000N), between the Board of Commissioners of Douglas County and Elmer L. Gray and Cathy L. Gray, husband and wife, for 0.419 acres of right-of-way easement and 0.436 acres of temporary easement for borrow (channel improvement), in the lump sum of \$1750. This lump sum payment includes allowance for installing two 25 ft. utility power poles and guy wires, reset electric meter and rewiring to water well pump, removing one utility pole located with proposed right-of-way and abstracting. After review of this contract it was moved by Mr. Neis that it be approved, seconded by Mrs. Hiebert, and carried unanimously.
