Young* At 8:11 a.m. it was moved by Mr. Neis that the Board go into executive session to discuss personnel matters with Ivan Flory, shop superintendent; David Berkowitz, attorney representing Mr. Flory; John Young, engineering technician IV in the public works department; Joe Jamison, division manager of highway operations; Kenneth Mather, superintendent; and Dan Young, county counselor. Motion seconded by Mrs. Bradley, and carried. Mr. Neis and Mrs. Bradley voted aye and Mrs. Hiebert voted nay. The Board resumed regular session at 9:03 a.m.

*Personnel; Employ
M. Peck* Ruth Foster, Valleyview administrator, appeared before the Board to recommend the employment of Mark V. Peck, in the position of maintenance supervisor, permanent, full-time, at the rate of \$6 per hour, effective August 13, 1984. After discussion it was moved by Mrs. Hiebert that this recommendation be approved with the condition that Mr. Peck cannot lift heavy objects up stairs or ladders due to a knee injury be documented in Phil Leonard's office, seconded by Mr. Neis, and carried unanimously.

J. Harper* The Board noted receipt of a memorandum from District Attorney Jerry Harper stating that K.S.A. 22a-105 provides that the district attorney "shall receive an annual salary equal to the salary provided for judges in K.S.A. 75-3120g." The salary of district judges was raised to \$51,411 on July 1, 1984. Therefore, Mr. Harper requested that the salary of Douglas County district attorney be raised retroactively to \$51,411 in order to comply with the law. After discussion it was moved by Mr. Neis that this request be approved, seconded by Mrs. Hiebert, and carried unanimously.

"Reality Therapy"* The Board discussed a request from Terrie Travis, community service work program coordinator, to attend the "Reality Therapy", Manhattan Counseling Services at Manhattan, Kansas, for a fee of \$50. After discussion it was moved by Mrs. Hiebert that this request be approved, seconded by Mr. Neis, and carried unanimously.

Purch envelopes* Treasurer Ruth Vervynck appeared before the Board with two telephone quotes for the purchase of 50,000 envelopes, 7-3/4" x 3 1/2". Mrs. Vervynck recommended that the Board accept the low quote from B & C, Kansas City, Kansas, in the amount of \$19.75 per thousand. After discussion it was moved by Mr. Neis that this recommendation be approved, seconded by Mrs. Hiebert, and carried unanimously.
