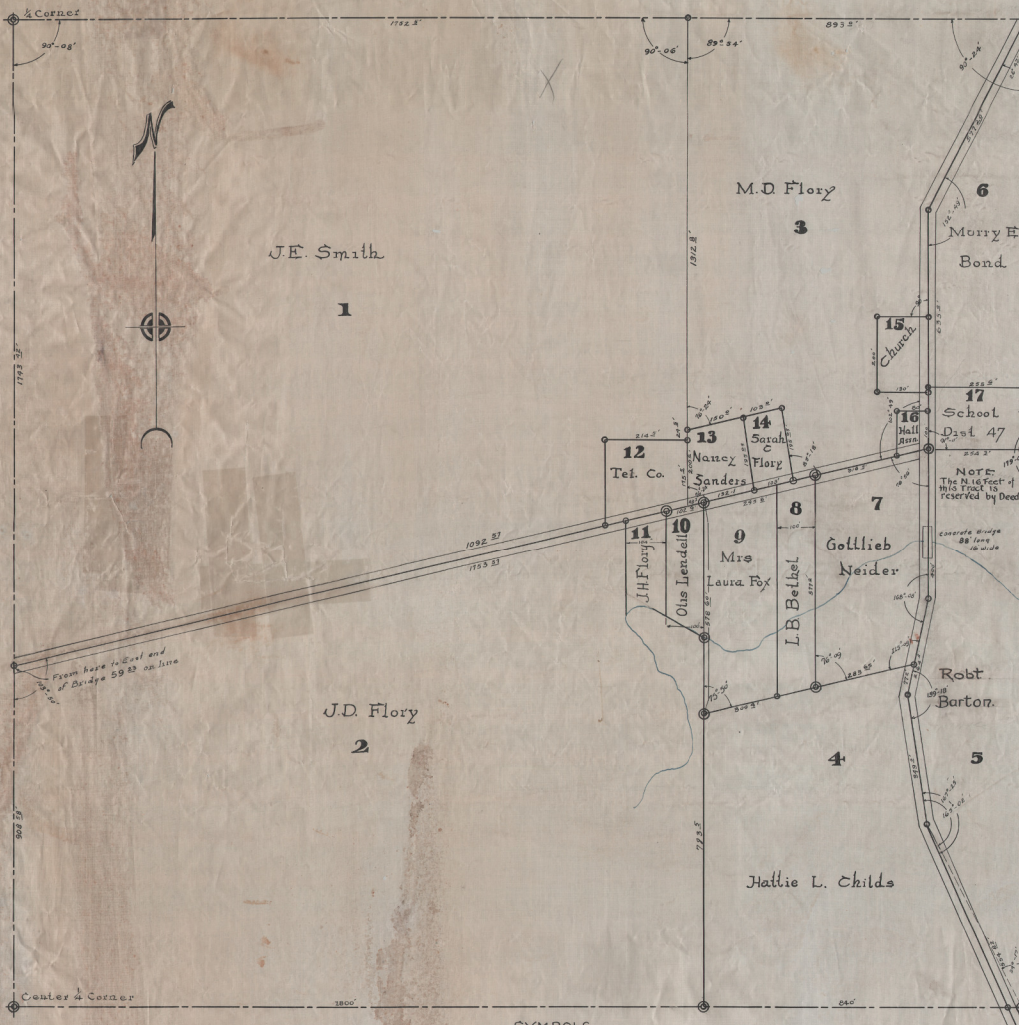


PLAT OF THE RESURVEY
