1 That Harold C. Fisher as Principal (hereinafter called Principal), and the

13 term beginning July 3, 1939 and ending July, 1941.

14 NOW, THEREFORE, if the Principal shall well and faithfully perform all and
15 singular the duties incumbent upon him by reason of his election or appointment
16 as such officer and honestly account for all moneys which shall have come accord-
17 ing to law into his hands as such officer, then this obligation shall be null
18 and void; otherwise it is to be and remain in full force and virtue.

20 the Surety has caused this instrument of writing to be signed by its Attorney
21 in Fact, and Resident Agent, and its corporate seal to be hereunto affixed,
