OFFICIAL BOND

KNOW ALL MEN BY THESE PRESENTS:

That we, Billy C. Hodson, as Principal, and UNIVERSAL SURETY COMPANY, incorporated under the laws of the State of Nebraska, with principal office in LINCOLN, NEBRASKA, as Surety, are held and firmly bound unto State of Kansas in penal sum of Ten Thousand and no/100 Dollars, lawful money of the United States, for which payment, well and truly to be made, we bind ourselves, our heirs, executors, administrators, successors and assigns, jointly and severally, firmly, by these presents.

WHEREAS, the said Billy C. Hodson has been elected to the office of Sheriff for the term of two years and 4 days from the 10th day of January, 1955; within and for the County of Douglas, State of Kansas.

NOW, THEREFORE, THE CONDITION OF THIS OBLIGATION IS SUCH, That if the said Billy C. Hodson shall well and faithfully perform all of the duties of said office during said term, then this obligation shall be void; otherwise it shall remain in full force and effect.

IT IS UNDERSTOOD AND AGREED between all parties hereto that if the Surety shall so elect it may cancel this bond at any time by written notice to the Obligee stating when thereafter the cancelation shall be effective, which shall not be less than thirty days after the date of mailing said notice by the Surety, if sent by mail, or not less than thirty days after delivery of said notice to the Obligee, if not sent by mail, and the Surety shall not be liable under this bond for any loss resulting from any act or acts committed by the Principal after the effective date stated in said cancellation notice. In the event of such cancelation the Surety shall, upon surrender of this bond and release of the Surety from all liability hereunder, refund the premium paid less a pro rata part thereof for the time this bond shall have been in force.

IT IS FURTHER UNDERSTOOD AND AGREED, and this bond is given and accepted on the condition that the Surety shall in no way be held liable for any loss, costs, damages or expenses of any kind caused by the failure of any Bank, Institution or Depository of any kind to pay, deliver over or properly account for any money, moneys, papers, securities or property of any kind placed on deposit therein or in its custody by or for said Billy C. Hodson as such Sheriff or in any other capacity.
