KNOW ALL MEN BY THESE PRESENTS, That we LOUIS H. GRIFFITH of Lawrence in the State of Kansas as Principal, and THE WESTERN CASUALTY AND SURETY COMPANY, of Fort Scott, Kansas, a corporation duly organized and existing under and by virtue of the laws of the State of Kansas, as surety, are held and firmly bound unto State of Kansas in the full and just sum of FIVE THOUSAND & NO/100- - - (\$5,000.00) Dollars, lawful money of the United States, for the payment of which well and truly to be made, we bind ourselves, our heirs, executors, administrators, successors and assigns, jointly and severally, firmly by these presents;

SIGNED AND SEALED this 26th day of November A. D., 1940.

WHEREAS, the said LOUIS H. GRIFFITH has been duly elected County Commissioner, Douglas County, Kansas for the term beginning January 13, 1941 and ending January 8, 1945

NOW THEREFORE, the condition of the above obligation is such, that if the above bounden LOUIS H. GRIFFITH shall well and faithfully perform all the duties of his said office of County Commissioner as required by law, then this obligation to be null and void; otherwise to be and remain in full force and virtue.

This bond is given and received under the following express conditions:

The term of this bond shall be from the 13th day of January, 1941, to the 8th day of January, 1945.

That if the Surety shall so elect, it may give notice in writing to State of Kansas terminating its liability under this bond for any default of the Principal occurring after the expiration of thirty (30) days from the date of such notice, and this bond shall be deemed cancelled at the expiration of thirty (30) days after such notice has been given.

That the Surety hereunder shall not be liable for any loss which may be sustained through the failure of any bank or banks or other depository to pay or deliver over any moneys and securities deposited with it by the said LOUIS H. GRIFFITH which may come into his hands by virtue of his said office.

POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS: That THE WESTERN CASUALTY AND SURETY COMPANY, of Fort Scott, Kansas, a corporation of the State of Kansas, having its principal office in the city of Fort Scott, Kansas, pursuant to the following By-Law, which was adopted by the Board of Directors of the said Company on March 22nd, 1929, to-wit:

And the execution of such bonds or undertakings in pursuance of these presents, shall be as binding upon said Company, as fully and amply, to all intents and purposes, as if they had been duly executed and acknowledged by the regularly elected officers of the Company at its office in Fort Scott, State of Kansas, in their own proper persons.
