WHEREAS, the said M. N. PENNY has been duly elected County Commissioner Douglas County, Kansas for the term beginning January 11 1943 and ending January 11, 1945

NOW THEREFORE, the condition of the above obligation is such, that if the above bounden M. N. PENNY shall well and faithfully perform all the duties of his said office of County Commissioner as required by law, then this obligation to be null and void; otherwise to be and remain in full force and virtue.

This bond is given and received under the following express conditions:

The term of this bond shall be from 11th day of January, 1943, to the 11th day of January 1947.

That if the Surety shall so elect, it may give notice in writing to State of Kansas terminating its liability under this bond for any default of the Principal occurring after the expiration of thirty (30) days from the date of such notice, and this bond shall be deemed cancelled at the expiration of thirty (30) days after such notice has been given.

That the Surety hereunder shall not be liable for any loss which may be sustained through the failure of any bank or banks or other depository to pay or deliver over any moneys and securities deposited with it by the said M. N. PENNY which may come into his hands by virtue of his said office.
