KNOW ALL MEN BY THESE PRESENTS, That we, FRANK R. GRAY, as principal and AMERICAN SURETY COMPANY, OF NEW YORK as his sureties, are indebted, held, and firmly bound unto the State of Kansas, in the sum of TWO THOUSAND AND NO/100 (\$2,000.00) Dollars, which we hereby bind ourselves to pay; but, however, upon this express condition, to wit:

THAT, WHEREAS, The above bounden FRANK R. GRAY was elected to the office of Probate Judge of said county, on the 8th day of November A.D. 1938 for a term of two years beginning January, 9, 1939 and ending January 13, 1941

NOW, THEREFORE, The condition of this obligation is such, that if the said Frank R. Gray shall well and faithfully, correctly^{and} impartially perform and execute the duties of the office of Probate Judge of said county, required of him by law, during his continuance in office, by virtue of said election, and shall make faithful application and payment of all moneys and effects that may come into his hands in the execution of the duties of his office, and deliver to his successor in office all books, records, papers, and other things belonging to his said office, which may be so required by law, then the above obligation shall be void; otherwise to be and remain in full force and effect.

THE ABOVE-NAMED SURETIES are to be, respectively, liable upon this obligation only to the extent of the amount set opposite their respective signatures below, as provided by the act of the Legislature of the State of Kansas, entitled, "An Act fixing the liability of sureties on official bonds," approved March 10, 1891.
