This Indenture made this 14th day of March 1881 between Lemuel King widower of Douglas County in the State of Kansas of the first part and H. V. Linton in the State of Georgia of the second part.

Witnesseth that the said party of the first part in consideration of the sum of Four Hundred Dollars the receipt of which is hereby acknowledged does by these presents grant bargain sell and convey unto the said party of the second part his heirs and assigns all the following described real estate situated in the County of Douglas and State of Kansas to wit: Lot number One hundred and fifteen (15) on Ohio Street in the City of Lawrence said lot being fifty (50) feet wide and running back One hundred and seventeen (17) feet to an alley in the rear of said lot To have and to hold the same Together with all and singular the tenements hereditaments and appurtenances therunto belonging or in any wise appertaining unto said party of the first part hereby covenant that he is this day the owner of said premises that the same are free from all encumbrance and that the will warrant and defend the same to the grantee his heirs and assigns forever.

Provided Always and these presents are upon this express condition that whereas said party of the first part has this day executed and delivered three promissory notes in writing to said party of the second part payable at the Banking House of John D. Henry & Co. Topeka Kansas bearing date March 14th 1881 one principal note for \$400.⁰⁰ due in 5 years after date and ten interest ^{notes} for \$6.⁰⁰ each one due in six months after date and one coming due at the end of each succeeding six months thereafter up to the maturity of the principal note and all said notes bear 12 per cent interest after due until paid.

Now if said party of the first part shall pay or causes to be paid to said party of the second part his heirs and assigns said sums of money in the above described notes mentioned together with the interest thereon according to the terms and tenor of the same and shall pay all taxes and assessments which are or may be levied and assessed against said premises or any part thereof and shall pay the premiums for the amount of insurance hereinafter specified and shall keep the buildings and fences on said premises in good repair and refrain from cutting and removing wood and timber from said premises and from the commission of ^{other} waste then these presents shall be void and otherwise shall remain in full force and effect. But if any of said notes or any part thereof or any interest thereon is not paid when the same is due or if the taxes and assessments of any nature which are or may be assessed and levied against said premises or any part thereof are not paid when the same become due and payable then all of said notes and interest thereon shall and by these presents do become immediately due and payable if the holder hereof so elects without
