in the year of our Lord one thousand eight hundred and eighty
between James E. Bailey & Sarah Bailey of Endora, in the
County of Douglas and State of Kansas of the first part and
Charles Albright of Endora, in the County of Douglas and State
of Kansas of the second part. Witnesseth, That the said parties
of the first part, for and in consideration, of the sum of Six
Hundred and Fifty Dollars to them duly paid, the receipt of
which is hereby acknowledged, have sold, and by these pres-
ents do grant, bargain, sell and mortgage to the said party
of the second part his heirs and assigns forever, all that tract
or parcel of land situate in the County of Douglas, and
State of Kansas, described as follows, to-wit: The North
West quarter of the South East quarter of Section Thirty-Three
(33) of Township Thirteen (13) Range Twenty One, (21) con-
taining 40 acres more or less. Also a strip of land situate
and one half 16th feet wide along the North line of the North
East quarter of Section Thirty-Three (33) of Township Thirteen
(13) Range Twenty One (21) said strip beginning on the North
East corner of the South East quarter of said section thence running
East Eighty rods, with the appurtenances, and all the estate
