

This Indenture made this 10<sup>th</sup> day of May  
in the year of our Lord one thousand eight hundred  
and eighty one between Ruth Lipsinger and John Lip-  
singer her husband of Clinton in the County of Douglas  
and State of Kansas of the first part and N. N. Osburn  
of Wilmington Illinois of the second part

Witnesseth, That the said parties of the first part in  
consideration of the sum of Two Hundred Dollars  
to them duly paid the receipt of which is hereby acknowl-  
edged have sold and by these presents do grant  
bargain sell and mortgage to the said party of the  
second part his heirs and assigns forever all that  
tract or parcel of land situated in the County of Doug-  
las and State of Kansas described as follows to wit,

Begin at the North East corner of North West quarter  
of Section Eighteen (18) Township Thirteen (13) Range Eighteen  
(18); West 81  $\frac{93}{100}$  Rods South 100 Rods West 60 Rods South  
60 Rods; East 131  $\frac{93}{100}$  Rods North 100 Rods to beginning.

Begin at the South East corner of South West quarter  
of Section Seven (7) Said Township <sup>4</sup> & Range North 100 rods  
West 50 rods South 100 rods East 50 Rods, less commencing 100  
rods north of S.E. cor. said Sec. 7 W 50 rods South 8  
rods 8 feet 3 inches; E 33 Rods to bank of dry branch; following  
said bank N. Ely to east line said quarter Section and to beg.

Also commencing 50 rods East of South West corner said S.W.  
Sec. (7) seven East 32 rods 7 feet North 12 rods 11 feet west  
32 rods 7 feet South 12 rods 11 feet to beg. with the appur-  
tenances and all the estate title and interest of the said

parties of the first part therin And the said Ruth  
Lipsinger and John Lipsinger do hereby covenant and  
agree that at the delivery hereof they are the lawful  
owners of the premises above granted and seized of a  
good and indefeasible estate of inheritance therein  
free and clear of all encumbrances This Grant is intended  
as a Mortgage to secure the payment of the sum of  
Two Hundred (200) dollars three years after date with  
interest payable annually at the rate of 10 per cent per annum  
according to the terms of one certain promissory this day  
executed and delivered by the said Ruth Lipsinger and  
John Lipsinger to the said party of the second part and  
this conveyance shall be void if such payment be made

as is herein specified But if default be made in  
such payment or any part thereof or interest thereon
