This Indenture made this Twenty first day of February in the year
 of our Lord one thousand eight hundred and eighty two by and between
 Ethan A. Sawin^{sr} & Lucina P. Sawin his wife of Holting in the County
 of Douglas and State of Kansas parties of the first part and
 Mr. J. Tennant of the town of Sheffield, County of Chautauque^{sr}
 State of New York party of the second part:

Witnesseth that the said parties of the first part in
 consideration of the sum of Five hundred (\$500) Dollars to them in
 hand paid the receipt whereof is hereby acknowledged do by
 these presents grant bargain sell and convey unto the said party
 of the second part his heirs and assigns all of that certain parcel
 of land or real estate situated in the County of Douglas and
 State of Kansas and particularly bounded and described as
 follows to wit:

Commencing at a point on the south line of the north-west
 quarter of Section nineteen (19) in Township Fourteen (14) of range Twenty
 (20) seventy (70) rods east of the south-west corner of said quarter and
 running north one hundred and sixty (60) rods parallel with
 the West line of said quarter section. Thence east eighteen (18) rods
 to lands sold to R. D. Hadeworth. Thence South-fifty five and
 sixty five one hundredths (55⁶⁵/₁₀₀) rods to south-west corner of land
 sold to said Hadeworth. Thence east sixty five (65) rods to the
 east line of said quarter section thence south-one hundred and
 four and thirty five one hundredths (104³⁵/₁₀₀) rods to south-east
 corner of said quarter section thence West on the south-line of
 said quarter section to the place of beginning containing fifty
 eight (58) acres more or less. To have and to hold the above
 described premises together with^{all} the right privileges hereditaments
 and appurtenances thereto belonging or in any wise
 appertaining to the said party of the second part his heirs
 and assigns forever.

And the said parties of the first part for themselves and
 their heirs executors and administrators covenant do and
 with the said party of the second part that the said parties of
 the first part lawfully seized in fee of the premises hereby
 granted and have good right to sell and convey the same as
 aforesaid that the said premises are free and clear from all
 encumbrance that they will and their heirs executors and
 administrators shall form warrant and defend the title to the
 said premises against the lawful claims and demands of all
 persons whomsoever.
