

This Indenture made this twentieth day of July 1882.
 between Nathan Norman Brown and Mary M. Brown his wife
 of Douglas County in the State of Kansas of the first part and
 Louisa M. Moore of Douglas County in the State of Kansas of the second part
 witnesseth, That the said parties of the first part in consider-
 ation of the sum of Six Hundred (\$600.) Dollars to them
 in hand by the said party of the second part before the de-
 livery of these presents the receipt whereof is hereby acknowledged
 have granted bargained and sold and by these presents do
 grant bargain sell and convey unto the said party of the sec-
 ond part her heirs and assigns forever all the following
 described real estate lying and situate in the County of Douglas
 and State of Kansas to wit; Beginning at the North west corner
 of the following described tract of land to wit, one sixth of the North
 East quarter of the West half (1/2) of Block No. Two (2), in North Law-
 rence according to the survey and plat of said North Lawrence
 recorded in the office of the Register of Deeds of Douglas County
 the said sixth lying immediately North of and adjoining the one
 third of said quarter Deeded to Jesse Wright by deed dated the
 sixth of November 1864 by Martha Robinson thence running South
 thirty seven and a half (37 1/2) feet, thence running East to the East line
 of said tract of land, thence North to the North line of said tract
 thence West to the place of beginning making the piece hereby con-
 veyed a rectangular piece thirty seven and a half (37 1/2) feet by the depth
 of the tract. Also a piece or parcel of land commencing at the
 South West corner of the one sixth (1/6) part of the North east
 quarter of the West half of Block No. Two (2), in said part
 of the City of Lawrence formerly known as North Lawrence
 according to the recorded Plat thereof Deeded to John Petty on
 the 10th day of June 1864 by Martha Robinson per Atty, the said
 one sixth (1/6) lying South of and adjoining the one third (1/3) of said
 Block Deeded to Unah B. Adams by deed dated June 6th
 1864, thence running North on the East line of Bridge Street
 in said city Twenty (20) feet thence East to the East line
 of the said West half of Block No. Two (2), thence South
 Twenty (20) feet to the southeast corner of the sixth (1/6) of said
 North east quarter of West half (1/2) of Block Two (2), Deeded
 to John Petty thence west to the place of beginning being
 Twenty (20) feet wide off the South side of said one sixth (1/6)
 To Have and to hold the same together with all and
 singular the tenements hereditaments and appur-
 tenances therunto belonging or in any wise apper-
 taining unto the said party of the second
