

thereof at the rate of twelve per centum per annum and the holder thereof may recover the whole amount of said bond with interest thereon at the rate of twelve per centum per annum from the date thereof, less the amount of such coupons and partial payments as shall have been paid, and may recover all amounts paid for taxes, assessments, insurance and to release or extinguish any statutory lien upon said premises or to protect the title or possession thereof, with interest thereon as provided herein and all may be included in the judgment rendered on amount found due in any suit to foreclose this mortgage and this mortgage is hereby made to secure all such sums.

It is further stipulated and agreed by the first party that upon the institution of proceedings to foreclose this mortgage, the plaintiff therein shall be entitled to have a receiver appointed by the court to take possession and control of the premises described herein and to collect the rents and profits thereof, under the direction of the court, without the proof required by statute: the amount so collected by such receiver to be applied under the direction of the court to the payment of any judgment rendered or amount found due upon the foreclosure of this mortgage.

In case this mortgage is foreclosed, the sale thereunder may be made with or without appraisal, at the option of the said second party, its successors or assigns.
