AFFIDAVIT

State of New York, County of New York, SS:

JOHN N. PENN, JR. being first duly sworn states that he is the Secretary and Executive Officer of The Board of the Church Erection Fund of the General Assembly of the Presbyterian Church in the United States of America, a Corporation, whose address is 156 Fifth Avenue, New York City, New York; that he has personal knowledge of the facts herein set forth, and has authority to make this affidavit.

THAT on the 27th day of JULY, 1878 THE PRESBYTERIAN CHURCH OF VINELAND, located in the City of VINELAND, in DOUGLAS County, Kansas executed and delivered to The Board of the Church Erection Fund of the General Assembly of the Presbyterian Church in the United States of America, a Corporation, its real estate (grant) mortgage in the amount of \$ 400.00, which said mortgage is filed for record in the office of the Register of Deeds of DOUGLAS County, Kansas, in Book W of Mortgages at page 634.

THAT said mortgage is still an obligation of said Church and is still a valid and subsisting lien on the property therein described.

THAT there is on this date due and unpaid on said mortgage the sum of \$ 400.00; no payment has been made on the debt secured by the above mortgage as no payment has become due according to the terms and provisions of said mortgage.

THAT said mortgage represents a loan of money made by the mortgagee to the mortgagor.

The real estate covered by said mortgage is described as follows:

"ALL that Tract or Parcel of Land Situated in Douglas County and State of Kansas described as follows to-wit:

"Commencing forty (40) feet West of the North East Corner of the Northwest 1/4 of the Northwest 1/4 of Section No. Fifteen (15) Township No. Fourteen (14) South of Range No. Twenty (20), East; thence South 125 feet; thence West 250 feet North 125 feet, East 250 feet to place of beginning."

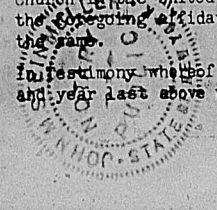
