This Indenture, made this 26th day of August, 1952, by The Meyer Sanitary Milk Company, a corporation organized under the laws of Kansas and having its principal office in Kansas City, Kansas (herein called the "Mortgagor"), to The Commercial National Bank of Kansas City, a corporation organized under the banking laws of the United States (herein called the "Mortgagee"), Witnesseth:

The Mortgagor, for and in consideration of the sum of One Hundred Thousand Dollars (\$100,000), the receipt of which is hereby acknowledged, does by these presents mortgage and warrant unto the Mortgagee, its successors and assigns, forever, the following described real property, to wit:

The east 62½ feet of lots 23 and 24, in block 13, in Grace Hill, an addition now in and a part of Kansas City, in Wyandotte County, Kansas.

The south 12 feet of lot 3 and all of lots 4 and 5 in St. Mary's Place, being a subdivision of the south 1/2 of block 152 in Wyandotte City, Kansas, now in and a part of Kansas City, in Wyandotte County, Kansas.

Lots 33, 34, 35, 36, 37, 38, and fractional lot 39, in block 2, in Connelly's Addition to Wyandotte City, now in and a part of Kansas City, in Wyandotte County, Kansas.

Lot 42 in block 5 in Connelly's Addition to Wyandotte City, now in and a part of Kansas City, in Wyandotte County, Kansas.

Lot 1 in Wyandotte Ferry Tract and Lot 9 in Van Possen's Subdivision of lot 13, Saw Mill Tract, all being in Kansas City, Wyandotte County, Kansas.

Lots 40 and 41 in block 5 in Connelly's Addition to Wyandotte City, now in and a part of Kansas City, in Wyandotte County, Kansas.

Lot 43 in block 5 in Connelly's Addition to Wyandotte City, now in and a part of Kansas City, in Wyandotte County, Kansas.

All of lots 13, 14, and 15, in block 2, in Nortonville, in Jefferson County, Kansas.

Lots 1, 2, and 3, in block 20, as platted in the southwest quarter of section 18, township 8 south of range 18 east in the City of Valley Falls (formerly the Town of Grasshopper Falls) according to the recorded plat thereof, in Jefferson County, Kansas.

Lots 9, 10, 11, and 12 in First Addition to the City of Valley Falls (formerly the Town of Grasshopper Falls), according to the recorded plat thereof, in Jefferson County, Kansas (said First Addition being sometimes referred to as Saphart's First Addition and sometimes referred to as Saphart's Addition.)
