This Indenture, made this 26th day of August , 1952, by The Meyer Sanitary Milk Company, a corporation organized under the laws of Kansas and having its principal office in Kansas City, Kansas (herein called the "Mortgagor"), to The Commercial Matienal Bank of Kansas City, a corporation organized under the banking laws of the United States (herein called the "Mortgagee"), Witnesseth:

The Mortgagor, for and in consideration of the sum of One Hundred Thousand Bollars (\$100,000), the receipt of which is hereby asknowledged, does by these presents mortgage and warrent unto the Mortgagee, its successors and assigns, forever, the following described real property, to wit:
