MORTGAGE

THIS INDENTURE, made this 14 day of July, 1953, between Paul Richard Anderson and Fae Ann Anderson, husband and wife, of Lawrence, in the County of Douglas, State of Kansas, of the First Part, and Hugh Means of Lawrence, in the County of Douglas, State of Kansas, of the Second Part.

WITNESSETH, that the said Parties of the First Part, in consideration of the sum of TEN THOUSAND AND NO/100 DOLLARS (\$10,000.00) to them duly paid, the receipt of which is hereby acknowledged, have sold and by these presents do grant, bargain, sell and mortgage to the said Party of the Second Part, his heirs and assigns, all that tract or parcel of land situated in the County of Douglas and State of Kansas, described as follows, to-wit:

The Northwest Quarter (1) of the Northeast Quarter (1) of Section Right (8), Township Thirteen (13)
South, Range Twenty (20) East, except 21 acres off the West side thereof and also except the following: The certain tract of land conveyed to the State Highway Commission by deed recorded in Book 164 at page 522 of the records in the office of the Register of Deeds of Douglas County, Kansas, and described as follows: Beginning at the Northwest corner of said Quarter Section; thence South along the West line 69.2afeet; thence East to a point on the East line 59.07 feet South of the Northeast Cuarter; thence North 59.07 feet to the Northeast Cuarter; thence North 59.07 feet to the North line of said Quarter Section; thence West along said North line to the place of beginning, except that portion lying in the West 21 acres of said Northwest Quarter of the Northeast Quarter.
