- 1. He will promptly pay the principal of and interest on the indebtedness evidenced by the said note, at the times and in the manner therein provided. Privilege is reserved to prepay at any time, without premium or fee, the entire indebtedness or any part thereof not less than the amount of one installment, or one hundred dollars (\$100.00), whichever is less.
- Together with, and in addition to, the monthly payments of principal and interest payable under the terms of the note secured hereby, the Mortgagor will pay to the Mortgagoe until the said note is fully maid:
 - (a) A sum equal to the ground rents if any and the taxes and special assessments next due on the premises covered by this mortgage, plus the premiums that will next become due and payable on policies of fire and other hazard insurance on the premises covered hereby (all as estimated by the Mortgage, and of which the Mortgagor is notified), less all sums already paid therefor, divided by the number of months to elapse before one month prior to the date when such ground rents, premiums, taxes and assessments will become delinquent, such sums to be held by Mortgagee in trust to pay said ground rents, premiums, taxes and special assessments, before the same become delinquent.
 - (b) The aggregate of the amounts payable pursuant to subparagraph (a) and those payable on the note accured hereby, shall be paid in a single payment each month, to be applied to the following in the order stated:
 - (I) ground rents, if any, taxes, assessments, fire and other hazard insurance premiums;
 (II) interest on the note secured hereby; and
 (III) amortisation of the principal of said nots.

The Mortgagee may collect a "late charge" not to exceed an amount equal to four far children of any installment which is not paid within fifteen (15) days of the due date thereof, but in no event shall this or other provisions be construed so as to authorise collection of any sum in excess of that permitted by law.
